To conduct business-related activities

Visa:

Business

Required documentation:

- Passport valid for at least six (6) months and at least two (2) blank pages at the time of entering Argentina.
- Two (2) current 4 x 4 cm photographs, facing the camera, printed in colour, on a white background.
- Visa application form filled out (preferably in electronic format) and signed by the applicant.
- Letter of invitation from the inviting party in Argentina.
- .Proof of commercial/work activity in the place of residence (for example, letter issued by the employer).
- Round trip reservation (Recommendation: do not purchase tickets before obtaining the visa).
- Hotel reservation or proof of accommodation in Argentina.

Allowed length of stay:

Sixty (60) days.

Purpose of the trip:

To attend congresses and fairs or to carry out technical, scientific, artistic, sport-related or professional activities.

Visa:

Technical

Required documentation:

- Passport valid for at least six (6) months and at least two (2) blank pages at the time of entering Argentina.
- Two (2) current 4 x 4 cm photographs, facing the camera, printed in colour, on a white background.
- Visa application form filled out (preferably in electronic format) and signed by the applicant.
- Letter of invitation from the inviting party in Argentina.

This letter is not required if the purpose of the trip is to attend a trade-related fair, exhibition or event. In this case, proof of registration to the event, if applicable, and business background evidence of the applicant is required instead.

- Proof of activity in the place of residence that relates to the required visa (work, study or other).
- Round trip reservation (Recommendation: do not purchase tickets before obtaining the visa).
- Hotel reservation or proof of accommodation in Argentina.

Thirty (30) days.

To work

Visa:

Working

Required documentation:

- Passport valid for at least six (6) months and at least two (2) blank pages at the time of entering Argentina.
- Two (2) current 4 x 4 cm photographs, facing the camera, printed in colour, on a white background.
- Visa application form filled out (preferably in electronic format) and signed by the applicant.
- Proof of address within the jurisdiction of the Embassy (such as a utility bill or other document that serves as proof).

-An apostilled or legalized certificate of good conduct issued by the competent authority of the countries where they resided for more than one year over the previous three years.

-Commitment to tell the truth or Sworn affidavit of their lack of a criminal record in other countries, signed before the Head of Consular Section.

-Employment contract signed by the employer and including the registration number of the contracting company with the National Registry of Petitioners on behalf of Foreign Applicants (RENURE). The signature of the company's representative must be certified by an Argentine Notary Public and the relevant Association of Notaries Public. If the host is not registered with RENURE, please call (54-11) 4317-0200/0303/0337 to complete the registration.

The application will sign the contract before the Head of the Consular Section of the Embassy.

Purpose of the trip:

This type of visa is available for the spouse, child or parent of an Argentine citizen. A foreign spouse, parent or child under the age of 18 (or older, if the child has a disability) of a foreign person with permanent residence in Argentina is also eligible for a family reunification visa.

Visa:**Family reunification****Required documentation:**

- Passport valid for at least six (6) months and at least two (2) blank pages at the time of entering Argentina.
- Two (2) current 4 x 4 cm photographs, facing the camera, printed in colour, on a white background.
- Visa application form filled out (preferably in electronic format) and signed by the applicant.
- Proof of habitual residence within the jurisdiction of the Embassy (such as a utility bill or other document that serves as proof).
- Certificate of vital record, depending on the relevant relationship (birth certificate for children and parents / marriage certificate in the case of spouses). If the document was not issued by Argentina, it must be apostilled or legalized.
- Certified copy of the National Identity Card (DNI) of the relative who is a national or a permanent resident of Argentina.
- Certificate of domicile of the relative who is a national or a permanent resident of Argentina.

-In the case of travellers aged 16 or older, an apostilled or legalized certificate of good conduct issued by the competent authority of the countries where they resided for more than one year over the previous three years.

-In the case of travellers aged 16 or older, Commitment to tell the truth or Sworn affidavit of their lack of a criminal record in other countries, signed before the Head of Consular Section.

-If the traveller is a minor, authorization by both parents / legal tutor in order to apply for the visa.

To study in Argentina for a period exceeding 365 days.

Visa:

Student + 365 days

Required documentation:

- Passport valid for at least six (6) months and at least two (2) blank pages at the time of entering Argentina.
- Two (2) current 4 x 4 cm photographs, facing the camera, printed in colour, on a white background.
- Visa application form filled out (preferably in electronic format) and signed by the applicant.
- Program of study.
- Electronic filing of the student data by the educational institution in the National Directorate of Migration.
- The educational institution must be duly registered with the National Registry of Petitioners on behalf of Foreign Applicants of Argentina (RENURE) and have their inscription number. If the host is not registered with RENURE, please call (54-11) 4317-0200/0303/0337 to complete the registration.
- Proof of sufficient funds to cover stay and study expenses (consular authorities may request copies of bank account statements, credit card statements, or other).
- In the case of travellers aged 16 or older, an apostilled or legalized certificate of good conduct issued by the competent authority of the countries where they resided for more than one year over the previous three years.
- In the case of travellers aged 16 or older, commitment to tell the truth or sworn affidavit of their lack of a criminal record in other countries, signed before the Head of Consular Section.

Visa:

Student - 365 days

Required documentation:

- Passport valid for at least six (6) months and at least two (2) blank pages at the time of entering Argentina.
- Two (2) current 4 x 4 cm photographs, facing the camera, printed in colour, on a white background.
- Visa application form filled out (preferably in electronic format) and signed by the applicant.
- Program of study.
- Electronic filing of the student data by the educational institution in the National Directorate of Migration.
- The educational institution must be duly registered with the National Registry of Petitioners on behalf of Foreign Applicants of Argentina (RENURE) and have their inscription number. If the host is not registered with RENURE, please call (54-11) 4317-0200/0303/0337 to complete the registration.
- Proof of sufficient funds to cover stay and study expenses (consular authorities may request copies of bank account statements, credit card statements, or other).

-In the case of travellers aged 16 or older travelling for a period exceeding 6 (six) months, an apostilled or legalized certificate of good conduct issued by the competent authority of the countries where they resided for more than one year over the previous three years.

-In the case of travellers aged 16 or older travelling for a period exceeding 6 (six) months, commitment to tell the truth or sworn affidavit of their lack of a criminal record in other countries, signed before the consul.

Required documentation:

-Passport valid for at least six (6) months and at least two (2) blank pages at the time of entering Argentina.

-Two (2) current 4 x 4 cm photographs, facing the camera, printed in colour, on a white background.

- Visa application form filled out (preferably in electronic format) and signed by the applicant.
- Proof of habitual residence within the jurisdiction of the Embassy (such as a utility bill or other document that serves as proof).
- An apostilled or legalized certificate of good conduct issued by the competent authority of the countries where they resided for more than one year over the previous three years.
- Commitment to tell the truth or Sworn Affidavit of their lack of a criminal record in other countries, signed before the Head of Consular Section.
- Copy of the employment contract or incumbency certificate issued by the company abroad (letter with company letterhead including position, years of service, monthly remuneration and contact information).
- Certificate issued by the subsidiary or host entity in the Argentine Republic, including the company's registration number with the National Registry of Petitioners on behalf of Foreign Applicants of Argentina (RENURE), the reason for the transfer, the duration of the stay in Argentina, monthly payment and contact person. If the host is not registered with RENURE, please call (54-11) 4317-0200/0303/0337 to complete the registration.

Purpose of the trip:

To conduct religious activities as a member of the catholic church clergy

Visa:

Members of the catholic church clergy

Required documentation:

- Passport valid for at least six (6) months and at least two (2) blank pages at the time of entering Argentina.
- Two (2) current 4 x 4 cm photographs, facing the camera, printed in colour, on a white background.
- Visa application form filled out (preferably in electronic format) and signed by the applicant.
- Proof of habitual residence within the jurisdiction of the Consulate (such as a utility bill or other document that serves as proof).
- In the case of travellers aged 16 or older, an apostilled or legalized certificate of good conduct issued by the competent authority of the countries where they resided for more than one year over the previous three years.
- In the case of travellers aged 16 or older, Commitment to tell the truth or Sworn affidavit of their lack of a criminal record in other countries, signed before the Head of Consular Section.

-Invitation letter containing the following information: a) Community, congregation or diocese where the member of the clergy will perform tasks; b) Type of work to be carried out (pastoral, community, teaching, etc.); c) Address and contact information of the religious entity; d) Name of superior/province or authority in charge; e) Length of stay in the Argentine Republic. The letter must be signed by a representative of the entity and submitted to the General Directorate for the National Registry of Religious Organizations of the Ministry of Foreign Affairs and Worship, which will certify the signature and notify the relevant Consulate in order to carry out the process. The Catholic Church is exempted from the National Registry of Petitioners on behalf of Foreign Applicants (RENURE) requirement.

Purpose of the trip:

To conduct religious activities as a member of non-catholic clergy

Visa:

Members of non-catholic clergy

Required documentation:

- Passport valid for at least six (6) months and at least two (2) blank pages at the time of entering Argentina.
- Two (2) current 4 x 4 cm photographs, facing the camera, printed in colour, on a white background.
- Visa application form filled out (preferably in electronic format) and signed by the applicant.
- Proof of habitual residence within the jurisdiction of the Consulate (such as a utility bill or other document that serves as proof).
- In the case of travellers aged 16 or older, an apostilled or legalized certificate of good conduct issued by the competent authority of the countries where they resided for more than one year over the previous three years.
- In the case of travellers aged 16 or older, Commitment to tell the truth or Sworn affidavit of their lack of a criminal record in other countries, signed before the Head of the Consular Section.
- Invitation letter containing the following information: a) Community, congregation or diocese where the member of the clergy will perform tasks; b) Type of work to be carried out (pastoral, community, teaching, etc.); c) Address and contact information of the religious entity; d) Name of superior/province or authority in charge; e) Length of stay in the Argentine Republic. The letter must be signed by a representative of the entity registered with the National Registry of Petitioners on behalf of Foreign Applicants (RENURE) and submitted to the General Directorate for the National Registry of Religious Organizations of the Ministry of Foreign Affairs and Worship, which will certify the signature. The letter must then be forwarded to the Consular Office where the visa application process is to be completed.

Purpose of the trip:

To have a long stay in Argentina, financed with income regularly produced by own resources brought from overseas or any other legal income from external sources.

Visa:

Rentier

Required documentation:

- Passport valid for at least six (6) months and at least two (2) blank pages at the time of entering Argentina.
- Two (2) current 4 x 4 cm photographs, facing the camera, printed in colour, on a white background.
- Visa application form filled out (preferably in electronic format) and signed by the applicant.

-Proof of habitual residence within the jurisdiction of the Consulate (such as a utility bill or other document that serves as proof).

-In the case of travellers aged 16 or older, an apostilled or legalized certificate of good conduct issued by the competent authority of the countries where they resided for more than one year over the previous three years.

-In the case of travellers aged 16 or older, Commitment to tell the truth or Sworn affidavit of their lack of a criminal record in other countries, signed before the Head of the Consular Section.

- Proof of the source of the funds and their transfer into the Argentina through banking or financial institutions authorized by the Argentine Central Bank, which are sufficient for the applicant's maintenance.

- Proof that the income is regular and sustained over time.

Allowed length of stay:

Up to one (1) year.

.....

Purpose of the trip:

1- To join an Argentine or foreign flag means of transportation as a crew member, or

2- In case the foreign traveller already arrives in Argentina as a crew member of a ship, aircraft or land vehicle: To enter Argentina for a short time before the resumption of the trip.

Exemption: Air crew members are not required visa in accordance with Annex 9 of the Chicago Convention on Aviation International Civil of 1944.

Visa:

Crew member

Required documentation:

-Passport valid for at least six (6) months and at least two (2) blank pages at the time of entering Argentina, or Seaman's Book.

-Two (2) current 4 x 4 cm photographs, facing the camera, printed in colour, on a white background.

-Visa application form filled out (preferably in electronic format) and signed by the applicant.

Before the visa application is sent to the Embassy, the maritime company in Argentina must formally register the visa request at the Port Control area (Área de Fiscalización Portuaria) of the Dirección Nacional de Migraciones (DNM).

Fee:

USD 40 | Exemption: Free-of-charge for Morocco and India passport holders

Allowed length of stay:

Up to ten (10) days.
